Dear Exhibitor:

As officers of the Utah Dermatology Society (UDS)*, we are writing to request an exhibitor fee from your company to support our 25th Annual UDS Conference, which will be held on May 1st and 2nd, 2026 in Moab, Utah. The meeting will be held at the Springhill Suites in Moab, Utah (1865 N Hwy 191, Moab, UT 84532).

As an exhibitor, your company will enjoy the opportunity to meet directly with the physicians before, during, and after the meeting. Your company will be allowed to set up displays right outside the door of the meeting room. Exhibitors will be acknowledged in a variety of ways including verbal acknowledgement at the beginning of each meeting session.

The meeting has been a great success in the past and continues to grow, with over 75 dermatologists, dermatopathologists, dermatology NP/PAs, and residents in attendance in past years. Most importantly, this is the single most well-attended meeting of dermatologists for the state of Utah, and there isn't a close second. This meeting provides a great opportunity for providers and industry to forge stronger relationships through educational and social opportunities. Each year, we recruit an outstanding faculty of nationally and internationally respected speakers, and 2026 will be no exception, with many international experts speaking on a host of general dermatology subjects.

The UDS is primarily an educational society which was formed in June 2001 to serve the specific needs of Utah dermatologists. The UDS is a not-for-profit organization founded to serve the community and promote excellence in patient care. This annual meeting is the primary way we achieve our educational mission. The exhibitor levels are as follows: Platinum level - \$8,500, Gold level - \$6,500, Silver level - \$4,500, and Bronze level - \$2,500

The tables will be located in the hotel's grotto which is located just outside the meeting room. The table location is based on the exhibitor level, with the closer spaces being the higher levels. Those at the Platinum level will have prime real estate and top billing.

When this is received, your company will be assigned an order based sponsorship level and order of registration compared to other companies within that level, which is how your table location at the conference will be determined. The UDS must receive payment for the display fee no later than April 1st, 2026 or you will forfeit any rights to that table.
